Project summary: The project seeks "to enhance climate-resilient livestock production and value chain development" and "focuses on promoting climate-smart agricultural practices, such as adopting crops and livestock farming; scale up early warning systems and conservation farming techniques to improve disaster preparedness and soil management."⁴

Environmental Safeguards Category: 2

Farm animal welfare standards: The project contains a farm animal welfare training component but the only reference to specific farm animal welfare standards is to the World Health Organization: "By adhering to WHO standards, [the project] can mitigate the risks of foodborne illnesses and contamination along the production, processing, and distribution stages of the value chain. Additionally, WHO recommendations on animal health and welfare contribute to sustainable livestock management practices, reducing the prevalence of zoonotic diseases and ensuring the well-being of both animals and farmers."

Environmental Safeguards Category: 2

Farm animal welfare standards: The project's Environmental and Social Assessment states that the project must follow Articles 30 and 31 of Côte d'Ivoire's Veterinary Public Health Code, ¹⁰ which contains a general reference to animal welfare but does not contain any specific standards regarding types of housing that are acceptable, stocking density guidance or any other relevant farm animal welfare indicators. ¹¹

Environmental Safeguards Category: 1

Farm animal welfare standards: The only evidence of farm animal welfare standards is the following reference to the Mozambique Regulation No. 26/2009 of 17 August in the Environmental and Social Impact Assessment: "The objectives of this Regulation are: a) To protect public health; b) Protect the domestic and export markets for animals, products of animal origin and others that may be directly or indirectly affected by animal diseases; c) Serve as a basis for carrying out epidemiological surveillance, control and eradication of diseases of

great economic importance and/or for public health; serve as a basis for compensation for losses caused by animal disease; e) Serve as a basis for the observance of animal welfare conditions. In the case of poultry slaughterhouses, Mozambique does not have specific legislation, and for this purpose animal health regulations and good international practices for the sector must be used."²⁴

The African Development Bank's farm animal welfare policy

The AfDB's Integrated Safeguards System (2023), Environmental and Social Operational Safeguard 6: Habitat and Biodiversity Conservation, and Sustainable Management of Living Natural Resources, 42 states: "The Borrower involved in the industrial production of crops and animal husbandry will follow GIIP to avoid or minimize adverse risks or impacts. The Borrower involved in large-scale commercial farming, including breeding, rearing, housing, transport, and slaughter, of animals for meat or other animal products (e.g. milk, eggs, wool) will use GIIP (e.g. International Finance Corporation's [IFC] Good Practice Note on Improving Animal Welfare in Livestock Operations) in animal husbandry techniques, with due consideration of religious and cultural principles. To minimize antimicrobial resistance, the Borrower shall only use antibiotics on healthy food producing animals, judiciously for the treatment of infection and as prescribed by a competent veterinary practitioner." 25

The African Development Bank's environmental safeguard categories

"Category 1: High-risk operations likely to cause significant and/or irreversible adverse environmental and/or social impacts on a large scale, or to significantly affect environmental or social components that the Bank or the borrowing country considers sensitive. This includes projects classified as high risk under national legislation or moderate-risk projects financed by the Bank in a low environmental and social (E&S) implementation capacity or fragile context.

Category 2: Moderate-risk operations likely to cause adverse E&S impacts that are lower than in Category 1 operations, medium-scale, easily reversible, and readily minimized by applying appropriate management and mitigation measures, or incorporating internationally recognized design criteria and standards. These include projects classified as moderate risk under national

legislation, or low-risk projects financed by the Bank in a lack of E&S implementation capacity or fragile context.

Category 3: Low-risk operations that do not directly or indirectly adversely affect the environment and that are unlikely to induce adverse social impacts. This category does not require a formal ESA although E&S mitigation or maximization measures may be included/recommended in the project design."²⁶
